Guidelines for completing Vetting Form (NVB 2)

Please read the following guidelines before completing this form. When returning this form please include a copy of your passport which is validated by your Group Leader or Local Garda Station, also proof of your current address is required

Miscellaneous

The Form must be completed in full using **BLOCK CAPITALS** and writing must be clear and legible. The Form should be completed in ball point pen.

Photocopies will not be accepted.

All applicants will be required to provide documents to validate their identity.

If the applicant is under 18 years of age, a completed NVB 3 - Parent\Guardian Consent Form will be required.

Section 1 Personal Details

Insert details for each field, allowing one block letter per box.

For Date of Birth field, allow one digit per box.

For Gender field please tick the appropriate box.

Please provide changes of names, if any, from birth i.e. name change due to marriage, deed poll, adoption.

For Place of Birth, please state County//State of birth as this is a mandatory field.

Please state Country of Birth as this is a mandatory field.

Please state your Passport Number where applicable.

PLEASE INCLUDE A COPY OF TITLE PAGE OF YOUR PASSPORT – Please validated your Passport your Group Leader/Local Garda Station

Please state your Mother's Maiden Name as stated on your birth certificate. Any fields not applicable to the applicant should be marked "N/A".

Section 2 Addresses - PLEASE PROVIDE PROOF OF CURRENT ADDRESS

Please enter all your previous addressees in chronological order.

The address fields should be completed in full, including Eircode/Postcode. No abbreviations. Insure that all years from birth to present are included.

Section 3 Self Disclosed Criminal Record
